







## Annual Report

Our mission: Provide and facilitate access to free, compassionate, quality health care for community members who are otherwise unable to obtain such services.





## Adapting and growing our services

Thanks to the generous support of our donors, funders, community partners, and volunteers, we've been able to successfully serve thousands of patients for the fiscal year 2022-



2023. We provided over 3,000 medical visits, 250 dental visits, and coordinated 525 specialty care appointments for uninsured individuals; this highlights the important role the Free Clinic plays as a safety net provider.

As Washington enters a new insurance landscape with the approval of waiver 1332, the Free Clinic is prepared to help assist our patients in the coming years in potentially new and exciting ways. Waiver 1332 allows everyone in the state of Washington, regardless of immigration status, to purchase insurance through the state's marketplace. This makes many thousands of people eligible to obtain insurance for the first time, including our patients. While affordability barriers likely remain, the Free Clinic will have staff available to get patients signed up for insurance who are interested and able, as well as answer questions about how to use their insurance.

The Free Clinic will continue to serve as a valuable resource for our patients, both in this new capacity as insurance navigators, and as primary care providers. For 33 years the Clinic has served uninsured residents of Clark County, and our hope is to build on our decades of experience to find sustainable and creative ways to adapt and grow our services. Our long-time healthcare partners in the community remain an invaluable part of these efforts; the Free Clinic Board of Directors, staff, and volunteers are excited to further develop these relationships to best meet the needs of our patients.






